Lernziele	After completing the module, students should be able to <ul style="list-style-type: none"> ■ Understand that economics is about the allocation of scarce resources, that scarcity forces choices and that every choice has an opportunity cost. ■ Understand how comparative advantage provides the basis for gains through trade. ■ List the determinants of the demand and supply for a good in a competitive market and explain how demand and supply together determine equilibrium price. ■ Understand the role of prices in allocating scarce resources in market economies and explain the consequences of government price controls. ■ Understand the costs of production and how profit-maximizing firms determine how much to produce. Be able to distinguish between long-run decisions and short-run decisions. ■ Distinguish between perfect competition and imperfect competition and be able to explain the welfare loss in non-competitive markets. ■ Understand the interdependence of market structure and firm behavior in specific industries.

The lecture contains an introduction into a part of microeconomics called industrial organization. This is the study of how market performance in a specific industry depends on market structure and market conduct. For example, industrial organization addresses the question, how the number of firms affects pricing decisions of individual firms and the efficiency of the overall outcome.
